Background

This *Quarterly Report* is submitted to EPA in accordance with paragraph Q. *Reporting Requirements* of Section VII *Remedial Actions* of the Consent Decree. *Quarterly Reports* are to be submitted to EPA within thirty (30) days of the end of each proceeding calendar quarter. This report covers progress of the County's I/I Improvements Program prior to and during the Second Quarter, 2023.

This Report contains the descriptive summary of Remedial Actions required in the Consent Decree.

Remedial Actions: Current Status

Phase 1

Submittal of the monthly *Summary of Unpermitted Discharges* is the only ongoing activity under Phase 1. *Summary* reports are submitted to EPA and the citizen plaintiffs and placed in the Public Document Repositories each month. Concurrent with the *Summary* reports, documentation in support of the subject month's wet-weather related discharges is submitted under the requirements of Section XI.

Phase 2

All deliverables due to date under Phase 2 have been submitted to EPA on schedule. There were no Phase 2 documents submitted to EPA during the Second Quarter, 2023.

Summary of Status of Phase 1 and Phase 2 Deliverables

The current status of all Phase 1 and Phase 2 deliverables is shown in the following Table I.

A status update meeting was held on January 10, 2022. A follow up meeting has not been scheduled.

Phase 3

Automatic Diversion Structures

- Watkins Branch was eliminated on July 31, 1995
- Hurricane Branch was eliminated on February 10, 1997
- Horse Farm was eliminated on June 11, 1997
- Barton Branch was eliminated on September 1, 2000
- Tarrant Springs Branch was eliminated on October 27, 2000

Cahaba River Collection System

The Cahaba River Collection System Rehabilitation was completed on April 1, 1999.

The Cahaba River Collection System Capacity Improvement Projects were completed on February 20, 2001.

Five Mile Creek Collection System

The Five Mile Creek Phase 1 Collection System Rehabilitation Upstream of Barton Branch (Contracts 1-7) was completed on May 31, 2004.

The Five Mile Creek Phase 2 Collection System Rehabilitation Downstream of Barton Branch (Contracts 8-20) was completed on June 27, 2006.

The Five Mile Creek Capacity Improvement Projects were completed on August 8, 2001.

Leeds Collection System

The Leeds Collection System was completed on January 1, 2000. The provisions of the Consent Decree applicable to the Leeds Complete Waste Treatment System were terminated April 23, 2012.

Prudes Creek Collection System

The Prudes Creek Collection System was completed on March 31, 2004.

The provisions of the Consent Decree applicable to the Prudes Creek Complete Waste Treatment System were terminated April 29, 2009.

Shades Creek Collection System

The Shades Creek Collection System was completed on August 21, 2006.

Trussville Collection System

The Trussville Collection System was completed on May 1, 1999.

The provisions of the Consent Decree applicable to the Trussville Complete Waste Treatment System were terminated February 23, 2009.

Turkey Creek Collection System

The Turkey Creek Collection System was completed on April 30, 2003.

The provisions of the Consent Decree applicable to the Turkey Creek Complete Waste Treatment System were terminated December 8, 2008.

Valley Creek Collection System

The Valley Creek Collection System was completed on August 30, 2006.

Village Creek Collection System

The West-area projects were completed on August 9, 2001. The East-area projects were completed on March 17, 2004.

Warrior Collection System

The Warrior Collection System was completed on July 16, 2003.

The provisions of the Consent Decree applicable to the Warrior Complete Waste Treatment System were terminated April 16, 2008.

Five Mile Creek WWTP

The Five Mile Creek WWTP Flow Metering and Sampling was completed on February 21, 2000.

Valley Creek WWTP

The Valley Creek WWTP Sludge Digestion was completed on February 26, 2001. Peak Flow Facilities Phase 5 Influent Pump Station was made fully operational on December 18, 2007.

Village Creek WWTP

The Village Creek WWTP Digestion and Dewatering was completed on January 10, 2001.

The Village Creek WWTP Peak Flow Facilities were completed on June 19, 2003.

Remedial Actions: Projected for Upcoming Quarter

Although not undertaken directly as a Consent Decree deliverable, the County is currently updating and/or consolidating its standard construction specifications. Specifications were available for public review and comment during the First Quarter, 2016. Comments were reviewed during the Fourth Quarter, 2016. Final specification issuance is projected during calendar year 2023. A revised CMOM was provided to EPA during the Fourth Quarter, 2016.

Phase 1

Submittal of the monthly *Summary of Unpermitted Discharges* to EPA and the citizen plaintiffs is the only activity under Phase 1 planned for the Third Quarter, 2023. Concurrent with the *Summary* reports, documentation in support of the subject month's wet-weather related discharges will also be submitted under the requirements of Section XI.

Phase 2

There are no Consent Decree Deliverables projected to be submitted to the EPA during the Third Quarter, 2023.

Phase 3

Cahaba River Collection System

Per the approved WTSCIP amendments No.1 and No. 5, evaluation of the rehabilitation results and performance of the Cahaba River Collection System continues.

A preliminary draft of the Cahaba River Complete Waste Treatment System Consent Decree Termination Plan was submitted on April 6, 2009 with comments due on or about May 20, 2009. The EPA responded with comments in a letter dated April 30, 2009. The Jefferson County Environmental Services Department responded to those comments in a letter dated May 29, 2009. The comments were discussed in a meeting between EPA and JCESD on October 19, 2009 in the EPA's Atlanta office. Dynamic hydraulic model calibration is complete; capacity analysis is complete. Basin optimization is completed. Remedial measures have been updated to include optimization results and updated model information. The 5-year model update is complete.

Five Mile Creek Collection System

Per the approved WTSCIP amendments No. 11 & 17, evaluation of the rehabilitation results and performance of the Five Mile Creek Collection System continues. Dynamic hydraulic model calibration is complete; capacity analysis is complete. Basin optimization is completed. Remedial measures have been updated to include optimization results. The 5-year model update is scheduled to be completed in 2024.

Leeds Collection System

The provisions of the Consent Decree applicable to the Leeds Complete Waste Treatment System were terminated April 23, 2012. Dynamic hydraulic model calibration is complete; capacity analysis is complete. Basin optimization is completed. Remedial measures have been updated to include optimization results. The 5-year model update is scheduled to begin in 2024.

Prudes Creek Collection System

The provisions of the Consent Decree applicable to the Prudes Creek Complete Waste Treatment System were terminated April 29, 2009. Dynamic hydraulic model calibration

is complete. Capacity assessment and remedial measures have been completed. The 5-year model update is scheduled to begin in 2024.

Shades Creek Collection System

Per the approved WTSCIP amendment No. 16, evaluation of the rehabilitation results and performance of the Shades Creek Collection System continues. Dynamic hydraulic model calibration is complete; capacity analysis is complete. Basin optimization is completed. Remedial measures have been updated to include optimization results and updated model information. The 5-year model update is complete.

Trussville Collection System

The provisions of the Consent Decree applicable to the Trussville Complete Waste Treatment System were terminated February 23, 2009. Dynamic hydraulic model calibration is complete; capacity analysis is complete. Basin optimization is completed. Remedial measures are being updated. The 5-year model update is complete.

Turkey Creek Collection System

The provisions of the Consent Decree applicable to the Turkey Creek Complete Waste Treatment System were terminated December 8, 2008. Dynamic hydraulic model calibration is complete; capacity analysis is complete. No remedial measures are required. The 5-year model update is scheduled to begin in 2024.

Valley Creek Collection System

Per the approved WTSCIP amendment No. 10, evaluation of the rehabilitation results and performance of the Valley Creek Collection System continues. Dynamic hydraulic model calibration is complete; capacity analysis is complete. Basin optimization is completed. The 5-year model update is complete. Remedial measures are being updated to include optimization results and updated model information.

Village Creek Collection System

Per the approved WTSCIP amendment No. 8, evaluation of the rehabilitation results and performance of the Village Creek Collection System continues. Dynamic hydraulic model calibration is complete; capacity analysis is complete. Basin optimization is

completed. Remedial measures have been updated to include optimization results. The 5-year model update is scheduled to begin in 2023.

Warrior Collection System

The provisions of the Consent Decree applicable to the Warrior Complete Waste Treatment System were terminated April 16, 2008. Dynamic hydraulic model calibration is complete; capacity analysis is complete. Capacity assessment and remedial measures have been completed. The 5-year model update is scheduled to begin in 2025.

Compliance and Non-Compliance with the Consent Decree

To date, the County has complied with the requirements of the Consent Decree with respect to deliverables and construction.

Unpermitted Discharges

Under the *Unpermitted Sewer Discharge Tracking and Reporting Program*, the County reports all known unpermitted discharges from the County-owned and operated sewers and treatment plants. Tracking, reporting and documentation for discharges occurring in the municipal systems are being reported separately from the County's systems.

Summary reports are submitted to EPA and the citizen plaintiffs, and placed in the Public Document Repositories, monthly. Additional documentation for the discharge events is also submitted to EPA monthly.
