Store licenses, including Chain Stores, as defined at §40-12-312 & §40-12-315 (Code of Alabama, 1975) require a full listing of each Store physically located in the State of Alabama. To lessen the processing time to issue a timely presented Chain Stores License billing statement, we encourage you to complete the form on the back of this cover letter (make copies as needed or attach a similar report). Unfortunately, you cannot renew your chain store license online. We are working hard to add the chain store license to the online renewal process, and we promise to make every effort to get this done by next renewal season.

If you added or deleted stores in Alabama, returning this information before the last business day of September will improve our ability to update the Chain Store records and send a corrected billing statement to assist in meeting the October 31 deadline.

In response to threats posed by bad actors and in compliance of §40-2A-10 those who rely on 3<sup>rd</sup> party vendors to report and remit any Jefferson County Department of Revenue liability, a Power of Attorney (POA) will authorize us to communicate with that vendor.
